 RSA 91-A:3 II (e) Consideration or negotiation of pending claims or litigation which has been threatened in writing or filed against the body or agency or any subdivision thereof, or against any member thereof because of his membership in such body or agency, until the claim or litigation has been fully adjudicated or otherwise settled.

 RSA 91-A: 3 II (f) Relative to adult parole board.

 RSA 91-A: 3 II (g) Relative to county correctional facilities.

 RSA 91-A: 3 II (h) Relative to business finance authority.

 RSA 91-A: 3 II (i) Consideration of matters relating to the preparation for and the carrying out of emergency functions, including training to carry out such functions, developed by local or state safety officials that are directly intended to thwart a deliberate act that is intended to result in widespread or severe damage to property or widespread injury or loss of life.

 RSA 91-A: 3 II (l) Consideration of legal advice provided by legal counsel, either in writing or orally, to one or more members of the public body, even where legal counsel is not present.

Arruda and Gray discussed an increase to the returning summer camp counselors' pay rate.

Courtney Price and Jackie DiFonzo were paid \$16/hour last year. Gray stated that the 2024 budget was planned with an hourly rate of \$18 for counselors.

Motion by Gray, seconded by Arruda to increase the hourly rate for summer camp counselors to \$18/hour. The motion passed 2-0 by roll call vote: Arruda – aye; Gray – aye.

In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
