Description of the discussion and final decisions: **The Board discussed a recommendation of the Rec Committee for the hiring of Elizabeth Arsenault for a part-time summer counselor position. The Board agreed with the Rec Committee’s recommendation.**

**Gray noted that the 2024 budget had planned for an hourly rate of \$18 for summer camp counselors.**

**Motion by Price, seconded by Arruda to hire Elizabeth Arsenault as a part-time summer camp counselor at a rate of \$18/hour. The motion passed 2-0-1 by roll call vote: Arruda – aye; Price – aye; Gray – abstained as she already voted as a member of the Rec Committee.**

Note: RSA 91-A:3(II) Minutes of proceedings in nonpublic session shall be kept and the record of all actions shall be promptly made available for public inspection, except as provided in this section. Minutes and decisions reached in nonpublic session shall be publicly disclosed within 72 hours of the meeting, unless, by recorded vote of 2/3 of the members present, it is determined that divulgence of the information likely would affect adversely the reputation of any person other than a member of the body or agency itself or render the proposed action ineffective. In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
