 RSA 91-A: 3 II (h) Relative to business finance authority.

 RSA 91-A: 3 II (i) Consideration of matters relating to the preparation for and the carrying out of emergency functions, including training to carry out such functions, developed by local or state safety officials that are directly intended to thwart a deliberate act that is intended to result in widespread or severe damage to property or widespread injury or loss of life.

 RSA 91-A: 3 II (l) Consideration of legal advice provided by legal counsel, either in writing or orally, to one or more members of the public body, even where legal counsel is not present.

Description of the discussion and final decisions: **Performance reviews were performed with Eric Cook and Jim Spambanato as requested by the Board at the June 9th meeting. J. Shackford is requesting**

that both employees rates of pay be increased to \$25.00/hour.

After discussion and review it was decided that based upon the performance reviews, being on par with other surrounding municipal wages and that this rate was accounted for and still able to be supported in the DPW budget, the Board unanimously agreed to the increases with a Motion by Price, seconded by Arruda.
