a) Veterans Tax credit: Committee discussed the best process to change the towns current wording that follows the old RSA to wording of the updated RSA that allows inclusion of all veterans who honorably served. Agreed that a Warrant Article on next year's ballot would be the cleanest way to make the change. Sweet agreed to develop preliminary wording for a Warrant Article to review at the June meeting.

- d) Quilts of Valor: Extensive discussion regarding the VSC's role and responsibility. Lowry to contact Clarice Girouard to get additional info regarding progress on quilt(s) and getting nominating info. Talked about distributing the QOV info and not act as a nominating committee. Tabled the rest of the discussion to the next meeting when we might have more info.
