**The Town will buy out Llewelyn’s contract from Ossipee which will be invoiced in the amount of approximately \$8,000 and paid from the full-time salary line.**

**Motion by Price, seconded by Gray to sign the full-time contract for Llewelyn. The motion passed 3-0.**
